ORIX Corporation was established in April 1964 as Orient Leasing Co., Ltd. by three trading companies and five banks that included Nichimen Corporation and the Sanwa Bank, which had paid particular attention to the future potential of the leasing industry in Japan, the Nissho Corporation, Iwai Sangyo Company, Toyo Trust Bank, Japan Kangyo Bank, Kobe Bank, and the Industrial Bank of Japan, commencing the business with a capital of 100 million yen (all the company names at the time).
