ORIX to Present at International Greentech & Eco Products Exhibition & Conference Malaysia 2010

TOKYO, Japan – October 8, 2010 – ORIX Corporation (TSE: 8591; NYSE: IX), a leading integrated financial services group, announced today that it will be presenting for four days at the International Greentech & Eco Products Exhibition & Conference Malaysia 2010 (IGEM2010) starting on October 14th and held in Kuala Lumpur, Malaysia.

IGEM2010 is the first such exhibition held by the Malaysian government and is a comprehensive environment and energy exhibition with the theme “A Green New Deal.” The exhibition area will be divided into five categories: Energy, Water & Waste Management, Building, Transportation and Eco Products & Services, with approx. 500 booths and an anticipated 120,000 visitors.

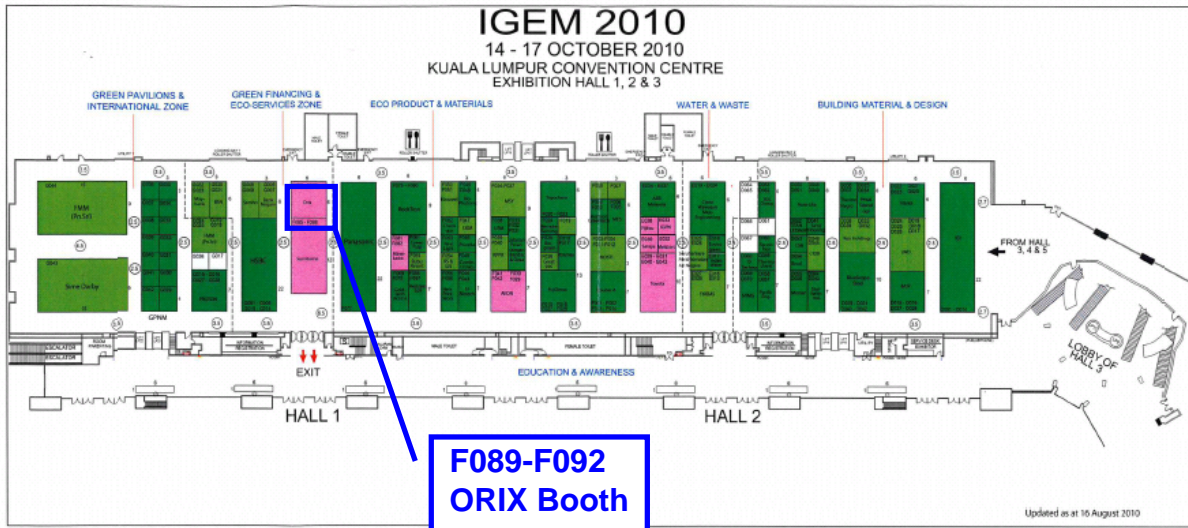

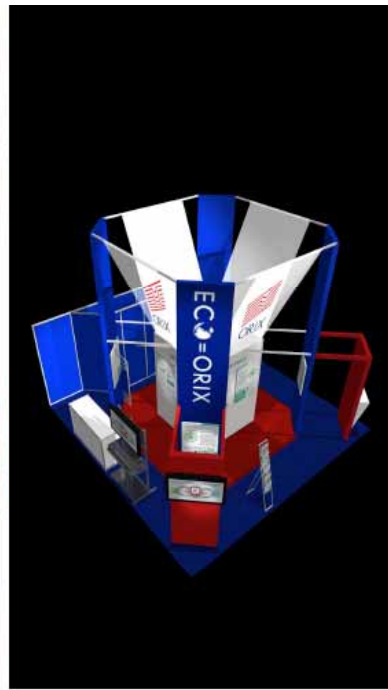
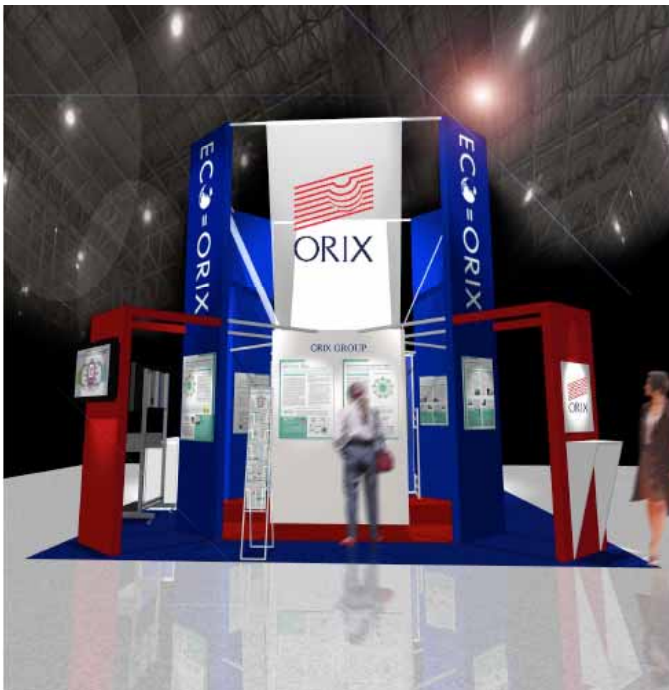
