ORIX Acquires Nihon Jisho

ORIX Corporation (TSE: 8591; NYSE: IX) acquired the operating assets and employees of Nihon Jisho Corporation on April 25, 2001. The assets include office buildings and residential rental properties owned and operated by Nihon Jisho, land for residential subdivision development, and shares in subsidiaries involved in building maintenance and real estate appraisal businesses. The company will be run as a separate entity under the same name. For the year ended March 31 2000, Nihon Jisho had assets of 57.5 billion yen, sales of 13.3 billion yen and pretax income of 900 million yen, while 71 employees were working at the company as of April 2001.

ORIX Corporation's 100%-owned subsidiary, ORIX Real Estate Corporation, is the core of a wide range of real estate related activities that include: 1) condominium and single dwelling subdivision development; 2) condominium, office building and company dormitory rentals; and 3) golf course, hotel and shopping center management. In November 2000, ORIX set up a 100%-owned subsidiary called ORIX Asset Management Corporation as a comprehensive real estate advisory company in preparation for the legalization of real estate investment trusts (J-REIT) in Japan.

ORIX will be able to use the 40 years' of experience and know-how of Nihon Jisho and its employees to further strengthen the ORIX Group's real estate development and operation capabilities. The real estate management and real estate appraisal subsidiaries that were also acquired will help ORIX extend the scope and specialization of its real estate business.
