

# ORIX Business Center Okinawa Corporation Becomes the First Company in Okinawa / Kyushu to Receive the "Eruboshi" Certification

TOKYO, Japan – June 3, 2016 – ORIX Business Center Okinawa Corporation ("OBCO"), a subsidiary of ORIX Corporation, today announced that it had been granted Eruboshi company certification by the Minister of Health, Labour and Welfare, in accordance with the Act on the Promotion of Women's Participation and Advancement in the Workplace. This is the first such recognition for corporations in Okinawa, a part of Kyushu region.



The Eruboshi company certification was established on April 1, 2016, a system where the Minister of Health, Labour and Welfare recognizes companies, based on set criteria, that

have implemented general employment action plans and have reported its implementation, and demonstrated superior performance to aid in the participation and advancement of women in the workplace.

The Eruboshi certification has three levels, depending on the number of criteria satisfied. OBCO was able to satisfy all of the criteria, and thus received the highest Eruboshi ranking of Level 3.

Going forward, OBCO intends to continue being a company in which employees can perform their jobs at any stage of life while exhibiting their own individuality and abilities, regardless of such factors as gender, by implementing a variety of supportive policies to ensure this aim is realized.
