

## Notice Regarding Absorption-Type Company Split of Interior Business Division

TOKYO, Japan – August 28, 2019 – ORIX Interior Corporation (“ORIX Interior”) announced today that it has decided to transfer its space design, planning, and construction business interior division into ORIX Facilities Corporation (“ORIX Facilities”) pursuant to an absorption-type company split (“the Company Split”). It is planned to complete the Company Split, after the prescribed procedures have been undertaken, on October 1, 2019.

### 1. Business of the Company Split

Interior business (Business related to design, production and construction of hotels, commercial facilities and FFE (Furniture, Furnishings, Equipment))

### 2. Reason for the Company Split

The business consolidation will be carried out for the purpose of strengthening the sales and order receiving systems, as part of the ORIX Group.

### 3. Method of the Company Split

ORIX Interior will be the splitting company and ORIX Facilities will be the succeeding company. After the Company Split, it will become the interior division of ORIX Facilities.
