



ORIX CarShare Introduce AI Powered Dash Cam “Nauto”

TOKYO, Japan - December 16, 2019 - ORIX Auto announced today that it will introduce an AI (Artificial Intelligence) powered Dash Cam/Driver Behavior Learning Platform, the “Nauto” to ORIX Carshare cars from December 16, 2019.

Nauto is a Dash Cam that uses two small high-quality cameras equipped with AI and communication functions to detect and record events occurring inside and outside of vehicles, analyzing the risk of driving in real time, and informing the driver with In-Vehicle Alerts. In addition to recording footage outside of vehicles, it supports safe driving by In-Vehicle Alerts when the driver is using a smartphone, falling asleep, and tailgating.

While “distracted driving”^(*) and “tailgating” has become a social problem, “Drive Recorders” that record driving conditions are becoming increasingly demanding as these devices protect the drivers themselves. From Fiscal 2016 to Fiscal 2018, the number of annual shipments has increased approximately 2.5 times in Japan.

This time, ORIX Auto will support the customers' safety and secure driving by introducing the “Nauto” in sharing cars. In addition, it is anticipated that driver records will prevent the violation of the lending rules, such as smoking inside the car. ORIX Auto will work to improve an environment in which members can use it more comfortably.

ORIX Auto will continue to improve its services so that customers can drive safely and with peace of mind.
