



## **ORIX to Issue 206th and 207th Unsecured Senior Debt Securities with Inter-bond Pari Passu Clause**

TOKYO, Japan – June 9, 2022 – ORIX Corporation (TSE: 8591; NYSE: IX) announced today that the issuance of its 206th unsecured senior debt securities for retail investors and 207th unsecured senior debt securities for institutional investors, both denominated in Japanese yen and with inter-bond pari passu clause, has been resolved in accordance with approval by the Board of Directors on June 25, 2021 and by the Representative Executive Officer on March 24, 2022.
