

Industry's First Event Planned and Operated by Students MULTI-CULTURAL FESTIVAL in SUGINOI HOTEL

TOKYO, Japan - September 15, 2022 - ORIX Real Estate Corporation ("ORIX Real Estate"), Ritsumeikan Asia Pacific University ("APU") and Suginoi Hotel And Resort Co., Ltd. announced that they will host the MULTI-CULTURAL FESTIVAL in SUGINOI HOTEL, the industry's first*1 event planned and operated by students, from November 25 to 27, 2022.

In December 2021, ORIX Real Estate and APU signed an Agreement on Friendly Exchange*2 for the purpose of industry-academia collaboration and have been promoting efforts to revitalize regional communities centering around tourism while students learn from ORIX's management knowledge and other expertise. As part of these efforts, students have taken the lead on furthering discussions with ORIX Group employees regarding the planning of new events at ORIX Group's Beppu SUGINOI HOTEL since April 2022. As a result, an event has been realized that features international performances and activities with APU students to experience the diversity of the world, the first event of its kind in the industry to be planned and operated by students.

This event will be held at the hotel's ACQUABEAT under the concept of "a festival of light and the world." It will feature dance and music performances on the main stage, as well as street-food around the world. Guests will also have the opportunity to create lanterns from various countries and float them in the pool at night in a mystical activity.

ORIX and APU will continue to seek regional attractions for tourists from Japan and overseas and will contribute to the Japanese tourism industry through the nurturing of diverse students.

2. About the ORIX Real Estate x APU Industry-Academia Collaboration



A wide range of industry-academia collaboration programs have been implemented since signing of an Agreement on Friendly Exchange in December 2021, including guest lectures by ORIX Real Estate employees, special summer session courses, and SUGINOI HOTEL tours. In September 2022, a Global Management (Capstone)*3 course is scheduled to be offered in cooperation with ORIX Bank Corporation. In addition to these programs, the MULTI-CULTURAL FESTIVAL in SUGINOI HOTEL is positioned as an annual event that symbolizes the efforts of industry-academia collaboration.

In the first semester, a Practical Learning program for learning from professional human resources was planned and implemented for a total of 13 days and over 75 hours between April 20 to July 17, 2022. Experts from various fields, including the SUGINOI HOTEL and government officials, were invited and students learned practical skills in planning, marketing, public relations, and other areas. In addition, the festival framework was created from scratch with professional creators and designers.

ORIX Real Estate will continue to nurture unique talents in project management, such as tourism and regional development, through an

annual program of classroom lectures and events.

It is a required course for 4th year students in the College of International Management.
