



# Expo 2025 Osaka, Kansai, Japan "Future Society Showcase Project" On-site port for Advanced Air Mobility to be Named "EXPO Vertiport"

TOKYO, Japan – October 8, 2024 – ORIX Corporation ("ORIX") and the Japan Association for the 2025 World Exposition ("the Association") announced that they have decided on the official name for the on-site takeoff and landing facility (vertiport)\* for Advanced Air Mobility ("AAM"), whose operations are sponsored by ORIX as part of the Future Society Showcase Project Exhibition at the EXPO 2025, Osaka, Kansai, Japan. The facility will be named "EXPO Vertiport."

The name "EXPO Vertiport" combines the term "EXPO," reflecting the expected high attendance at the EXPO 2025, with "Vertiport," a term commonly used for takeoff and landing areas for AAM. ORIX and the Association decided on the name in hopes of promoting the term "Vertiport" starting with the EXPO 2025.


