

GRAND GREEN OSAKA South Wing Grand Opening Creating an Area That Captivates the World

TOKYO, Japan – March 21, 2025 – The joint venture of nine companies ("JV9")*1 led by Mitsubishi Estate Co., Ltd., announced that the South Wing of GRAND GREEN OSAKA celebrated its grand opening today.

GRAND GREEN OSAKA is an area located at UMEKITA PARK, an urban park spanning approximately 4.5 hectares, and is composed of various facilities, including hotels, commercial facilities, and the innovation platform JAM BASE. Since its advance opening in September 2024, the area has welcomed over 10 million visitors, who have enjoyed spending time in diverse ways around the park.


The South Wing is a multifunctional complex*2 with diverse facilities such as 55 shops and restaurants, two hotels*3, office spaces, wellness facilities, and MICE facilities. It is directly connected to JR Osaka Station, the largest terminal station in western Japan, which provides access to Kansai International Airport and Shin-Osaka Station, attracting both business and leisure visitors from around the world.

Under the planning concept of "Creating 'Osaka MIDORI LIFE'" and "Combining 'MIDORI' and 'Innovation'", JV9 will continue to offer valuable and engaging experiences by collaborating with visitors, MIDORI Partners*4, and various facilities, sharing the unique appeal of GRAND GREEN OSAKA with the world.
