



ORIX Auto and Nihon Parking Collaborates in Car Sharing and Parking Businesses

TOKYO, Japan – October 10, 2017 – ORIX Auto Corporation (“ORIX Auto”) and Nihon Parking Corporation (“Nihon Parking”) announced today that they have entered into an Agreement on collaboration in their car sharing and parking businesses.

ORIX Auto has established ORIX Car Sharing Stations at Nihon Parking parking lots. By the end of FY 2017, it is scheduled to open 150 car sharing stations at approximately 300 parking lots with a capacity of 10 automobiles or more in the Metropolitan Area. Following this, it will expand stations to the Chubu and Kansai Regions.

In order to further increase customer convenience, ORIX Auto will offer mutual passenger transportation and preferential services for car sharing members. First, it is planning to offer discount parking for ORIX car sharing members at select parking lots in the Metropolitan Area.

Nihon Parking, which manages the parking business for Tokyo Tatemono Group, made Japan Total Service Co., Ltd. a wholly owned subsidiary in October 2016, and in December 2016, integrated three companies, Shinsoki Co., Ltd., Yours Corporation, and YS Park Co., Ltd., for business expansion. Currently, Nihon Parking operates a coin parking business at 1,580 locations with 65,109 parking spaces (as of the end of June 2017) through five brands, NPC24H, J.PARK, Friend Park, Y’S PARK, and PIT IN 100.

ORIX Auto operates automobile leasing, rental car, and car sharing businesses. It has worked to spread the car sharing service and increase customer convenience through a wide range of measures in cooperation with a railway company and other industries since it launched Japan’s first car sharing service in Yokohama City in 2002. As of the end of September 2017, ORIX Auto has approximately 180,000 members at 1,570 bases with 2,660 parking spaces.

Nihon Parking and ORIX Auto will continue to work on increasing customer convenience in response to a wide range of customer needs utilizing the strengths of both companies.
